ELECTRIC VEHICLE SUBSCRIPTION PROGRAM

Connexus Energy supports the growing electric vehicle (EV) market and wants to work with members who purchase an EV to make sure you get a rate to meet your charging needs. **Two categories of electric vehicles are eligible:** plug-in electric vehicles (PEV) and plug-in hybrid electric vehicles (PHEV). Hybrid electric vehicles (i.e., Toyota Prius) do not qualify.

TIER 1 EV SUBSCRIPTION RATE

\$30/Month (Per EV)	
Time of Day	Rate
9 p.m. – 9 a.m. (off-peak period)	600 kWh limit included in subscription
9 a.m. – 9 p.m. (peak period)	21¢/kWh

TIER 2 EV SUBSCRIPTION RATE

\$50/Month (Per EV)	
Time of Day	Rate
9 p.m. – 9 a.m. (off-peak period)	1,200 kWh limit included in subscription
9 a.m. – 9 p.m. (peak period)	21¢/kWh

Definition of Periods

The peak period is defined as those hours between 9:00 a.m. and 9:00 p.m. central prevailing time (CPT) year-round. The off-peak period is defined as those hours between 9:00 p.m. and 9:00 a.m. CPT year-round.

Tier 1 Designation

If the recorded six-month average off-peak usage exceeds 600 kWh, the member will be placed on the Tier 2 Subscription Rate in the next billing month. Once a member is on the Tier 2 Subscription Rate, their billing usage must be less than 600 kWh for 12 consecutive months before they have the option of switching back to the Tier 1 Subscription Rate.

Tier 2 Designation

If the recorded usage exceeds 1,200 kWh of off-peak usage in 3 months out of a 12-month period, the member will be placed on the Time-of-Day Rate in the next billing month.

After 12 months on the Time-of-Day Rate, the member may change to the subscription rate that fits their usage if it is within the program parameters. If the six-month average off-peak usage exceeds 600 kWh, the member will be placed on the Tier 2 Subscription Rate in the next billing month. Once a member is on the Tier 2 Subscription Rate, their billing usage must be less than 600 kWh for 12 consecutive months before they have the option of switching back to the Tier 1 Subscription Rate.



\$500 Rebate Available

Install a Level 2 EV charger and off-peak meter socket equipment to get a rebate up to \$500. Rebate forms available online at connexusenergy.com. Rebate is eligible for plug-in electric vehicles (PEV) only. **Plug-in hybrid electric vehicles (PHEV) or hybrid electric vehicles (HEV) do not qualify for the rebate offer.**

HOW TO SIGN-UP

1. Enroll in the program online at connexusenergy.com or call Member Services at 763.323.2650.
2. Contact Connexus Energy to schedule a date and time to pickup the required metering equipment.
3. Have a state electrical inspection completed within 30 days of metering equipment installation.
4. Contact Connexus Energy at 763.323.2650 for final inspection. Subscription rates will not apply until final inspection is complete.
