How to Apply for Rebate

1. Applications must be submitted by December 31, 2024.
2. Fill out this form completely, sign, and date it. Incomplete forms cannot be processed.
3. Attach all itemized invoices/receipts for the project, proof of PHEV purchase, and proof of electrical inspection.
4. Rebates are capped \$100 per PHEV and PHEV charger with off-peak meter socket installation.
5. Email, mail, or fax completed rebate form and supporting documents to Connexus Energy.

6. Rebates will be applied to your Connexus Energy bill upon verification of installation.
7. Please allow 6-8 weeks for processing.

Rebate Qualifications

- Rebate amount is \$100 for qualifying Level 2 (240-volt) PHEV charger with meter socket installation.
- Must be enrolled in an electric vehicle rate.
- Limit of one rebate per PHEV and PHEV charger with off-peak meter socket installation.
- PHEV charger must be installed within Connexus Energy's service territory.
- Eligible for plug-in hybrid electric vehicles (PHEV) only. Hybrid electric vehicles (HEV) do not qualify.
- The Whole-House Residential Time-of-Day Program does not qualify.
